WHEREAS, under the Declaration of Covenants, Conditions, and Restrictions for the Champions Estates Residential Owners' Association, recorded in Volume 5571, Page 1833 of the Official Public Records of Bexar County, Texas. WHEREAS, the Board believes that it is in the best interest of the Association and the Owners to establish a road use fee to be collected upon construction of a home, swimming pool, guest house or other improvement that would require the use of trucks class 7 and above. A non-refundable road use fee of five hundred dollars (\$500) will be paid to the Association for the Association's operating fund.

NOW THEREFORE, the Board resolves as follows:

Effective July 7, 2016, a road use fee in the amount of five hundred dollars (\$500) shall be collected upon construction of a home, swimming pool, guest house or other improvement that would require the use of trucks class 7 and above. A road use fee in the amount of five hundred dollars (\$500) will be paid by the owner of the home to the Association for the Association's operating fund.

The Board will be permitted to modify any road use fee payable on construction of a home, swimming pool, guest house or other improvement that would require the use of trucks class 7 and above. Except as set forth above, each initial road use fee will be collected before the construction is non-refundable.
