I.

Article IV is amended to add the following Section to read as follows:

Section 4.04. "Leases." No lot, nor any portion of any lot, maybe leased or rented for a term of less than six months, except for leases between buyers and sellers incident to the sale of a residence.

Thus approved by Owners entitled to cast sixty-seven percent of all votes of all the Owners, as certified by the signature of the President and Secretary of the Association below.
